**Project Applicant:** Radius Recycling (formerly Schnitzer Steel Industries, Inc.)

**Notice:** Notice is hereby given that the Port of Oakland (Port), acting as Lead Agency under the California Environmental Quality Act (CEQA), will receive public comment and recommendations on a draft Initial Study (IS)/Negative Declaration (ND) for the Radius Recycling Storage Tent Project (the project). The review period extends for 45 days beginning December 4, 2023, and ends at 5:00 pm on January 18, 2024. All comments regarding the draft IS/ND must be received by this ending date/time. The Port intends to approve a Port development permit for the project upon adoption of the final IS/ND.

**Project Location:** The project site is located at the Radius Recycling Oakland facility, 1101 Embarcadero West, Oakland, California 94607.

**Project Description:** Radius Recycling is proposing to construct and operate a 14,000 square-foot containment tent near the eastern boundary of its Oakland facility at the Port of Oakland. The tent would be used for containment of recyclable non-ferrous scrap metals (metals that do not contain iron) recovered from the facility's recycling process.

**Potential Environmental Impacts:** No significant, unavoidable impacts have been identified.

**Comment Period:** The public review period for the draft IS/ND extends from December 4, 2023, and ends at 5:00 p.m. on January 18, 2024.

**Locations Where Document Can Be Reviewed:** The Port has prepared a draft IS/ND for the subject project pursuant to CEQA.
