

NOTICE OF SOLICITATION OF BIDS

The CITY OF OAKLAND, acting by and through its BOARD OF PORT COMMISSIONERS (the "Port"), will receive sealed Bids at the office of the Secretary of the Board of Port Commissioners, located at Room 629, 530 Water Street, Oakland, California, until 12:00 noon on Thursday, January 4, 2018, for the following public work:

REPLACEMENT OF FENDER SYSTEMS AT BERTH 25 OUTER HARBOR OAKLAND, CALIFORNIA

The work of this 200 calendar day project consists, in general, of furnishing all labor, materials, appliances, tools, equipment, transportation, services and supervision required to replace existing fender systems at Berth 25, including, but not limited to: removing and disposing existing fender systems, furnishing and installing new equivalent fender systems; and performing all associated work, all in accordance with the Contract Documents.

The Engineer's estimate for this project is \$435,000.00.

A California Class A contractor's license is required to bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract.

No contractor or subcontractor may be listed on a bid proposal or awarded any contract for the project unless registered with the Department of Industrial Relations (DIR) pursuant to Labor Code section 1725.5, with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a).

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

This contract is subject to prevailing wage provisions, as specified in Document 00100, Invitation to Bid, and Document 00200, Instructions to Bidders, of the Project Manual.

The Port will conduct a pre-bid meeting at 9:00 AM on Wednesday, December 20 2017 in the Board Room, Second Floor, Port of Oakland Building, 530 Water Street, Oakland, California.

The Port strongly recommends that potential Bidders attend the pre-bid meeting. The pre-bid meeting will last approximately one hour, and will address the Port's Non-Discrimination and Small/Local Business Utilization Policy, insurance requirements, bonds, Maritime and Aviation Project Labor Agreement and any other special working conditions for this contract.

The Port will conduct a Site inspection tour at 10:15 A.M. on Wednesday, December 20, 2017, immediately following the pre-bid meeting. Bidders should meet for the Site inspection tour in front of the entrance to the Port of Oakland Building, 530 Water Street, Oakland, California. Bidders shall contract Gerard Higareda, at (510) 627-1320 at least 24 hours prior to the scheduled tour date and time to confirm arrangements and participate in any of the inspection tours. Bidders will be taken in Port vans to the Site. Bidders who fail to contract Gerard Higareda prior to the scheduled date and time may not be eligible to participate in the tour.
