## BERTHS 35-38 PAVEMENT REPLACEMENT OAKLAND, CALIFORNIA

The work of this 25 calendar day project consists, in general, of furnishing all labor, materials, appliances, tools, equipment, transportation, services and supervision required for the removal and replacement of asphalt pavement, including, but not limited to: accommodating the schedule of the terminal operator, mobilization/demobilization, milling existing pavement to a depth of 3", loading all asphalt grindings generated and hauling them to the Grindings Disposal Site, dumping, spreading, grading, and compacting the asphalt grindings in 2" thick lifts at the Grindings Disposal Site, placing of new asphalt; and performing all associated work, all in accordance with the Contract Documents.

The Engineer's estimate for this project is \$650,000.

A California Class A contractor's license is required to bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract.

No contractor or subcontractor may be listed on a bid proposal or awarded any contract for the project unless registered with the Department of Industrial Relations (DIR) pursuant to Labor Code section 1725.5, with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a).

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

This contract is subject to prevailing wage provisions, as specified in Document 00100, Invitation to Bid, and Document 00200, Instructions to Bidders, of the Project Manual.

The Port strongly recommends that potential Bidders attend the pre-bid meeting.
