

## **NOTICE OF SOLICITATION OF BIDS**

The CITY OF OAKLAND, acting by and through its BOARD OF PORT COMMISSIONERS (the "Port"), will receive sealed Bids at the office of the Secretary of the Board of Port Commissioners, located at Room 629, 530 Water Street, Oakland, California, until 12:00 noon on Friday, March 16, 2018, for the following public work:

### **BERTHS 35-38 PAVEMENT REPLACEMENT OAKLAND, CALIFORNIA**

The work of this 25 calendar day project consists, in general, of furnishing all labor, materials, appliances, tools, equipment, transportation, services and supervision required for the removal and replacement of asphalt pavement, including, but not limited to: accommodating the schedule of the terminal operator, mobilization/demobilization, milling existing pavement to a depth of 3", loading all asphalt grindings generated and hauling them to the Grindings Disposal Site, dumping, spreading, grading, and compacting the asphalt grindings in 2" thick lifts at the Grindings Disposal Site, placing of new asphalt; and performing all associated work, all in accordance with the Contract Documents.

The Engineer's estimate for this project is \$650,000.

A California Class A contractor's license is required to bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract.

No contractor or subcontractor may be listed on a bid proposal or awarded any contract for the project unless registered with the Department of Industrial Relations (DIR) pursuant to Labor Code section 1725.5, with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a).

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

This contract is subject to prevailing wage provisions, as specified in Document 00100, Invitation to Bid, and Document 00200, Instructions to Bidders, of the Project Manual.

The Port will conduct a pre-bid meeting at 9:00 AM on Tuesday, March 6, 2018 in the Board Room, Second Floor, Port of Oakland Building, 530 Water Street, Oakland, California.

The Port strongly recommends that potential Bidders attend the pre-bid meeting. The pre-bid meeting will last approximately one hour, and will address the Port's Non-Discrimination and Small/Local Business Utilization Policy, insurance requirements, bonds and any other special working conditions for this contract.

The project site is a restricted area. The Port will conduct a Site inspection tour at 10:00 AM on Tuesday, March 6, 2018, immediately following the pre-bid conference. Bidders should meet for the Site inspection tour in front of the entrance to 530 Water St., Oakland CA 94607. Bidders should contact Edwin Draper, at (510) 627-1269, at least 48 hours prior to the scheduled tour date and time to confirm arrangements and register for the inspection tour by providing the tour participant's full name, date of birth, telephone number and company name. A Government issued photo ID will be required for entry into the project site. Bidders will be taken in Port vehicles to the Site. Bidders who fail to contact Edwin Draper as required above may not be eligible to participate in the tour.
