MAINTENANCE DREDGING AND FURNISHING PILE DRIVER CREW FOR REPAIRS TO DOCKS AND WATERFRONT FACILITIES FOR PORT OF OAKLAND FOR THE PERIOD COMMENCING JULY 1, 2019 AND ENDING JUNE 30, 2020, 2021, OR 2022 OAKLAND, CALIFORNIA

The Work of this annual contract consists generally of on-call regular maintenance dredging of Port of Oakland berths, and on-call as-needed pile driving and repair of wharves and other maritime structures. Maintenance dredging includes disposing of suitable for unconfined aquatic disposal (SUAD) material at various possible sites, including but not limited to; the U.S. Army Corps of Engineers' (USACE) Alcatraz Disposal Site (SF-11), the Montezuma Wetlands Project (MWP), and/or the San Francisco Deep Ocean Disposal Site (SF DODS). The work may include off-loading not suitable for unconfined aquatic disposal (NUAD) material at the Berth 10 Rehandling Facility, and later disposing of the material after dewatering. The work may also include underwater grading of some berth areas.

The estimated cost of the work to be performed under this contract is approximately \$3,000,000 per year, but in no case will the cost of work to be performed during the maximum three year term of the contract exceed \$9,000,000, unless subsequently approved by the Board.

A California Class A contractor's license is required to bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract.

No contractor or subcontractor may be listed on a bid proposal or awarded any contract for the project unless registered with the Department of Industrial Relations (DIR) pursuant to Labor Code section 1725.5, with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a).

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

This contract is subject to prevailing wage provisions, as specified in Document 00100, Invitation to Bid, and Document 00200, Instructions to Bidders, of the Project Manual.

The Port will conduct a pre-bid meeting at 9:30 A.M. on Tuesday, April 9th, 2019 in the Board Room, Second Floor, Port of Oakland Building, 530 Water Street, Oakland, California. It is strongly recommended that bidders attend the pre-bid meeting. The pre-bid meeting will last approximately one hour, and will address the Port's Non-Discrimination and Small/Local Business Utilization Policy, insurance requirements, bonds, and any other special working conditions for this contract.
