REQUEST FOR QUALIFICATIONS (RFQ) FOR ON-CALL ENGINEERING DESIGN SERVICES FOR FEDERALLY FUNDED PROJECTS AT THE PORT OF OAKLAND

The Port of Oakland ("Port") is soliciting Statement of Qualifications (SOQs) from qualified civil engineering firms/teams (Consultants) to provide as-needed engineering services for design and preparation of plans and specifications for various development and maintenance projects to be constructed at the Oakland International Airport, and the Port's Maritime and Commercial Real Estate areas.

The Port is concurrently issuing two RFQs for the above Work:

Request for Qualifications (RFQ) for On-Call Engineering Design Services for Federally Funded Projects at the Port of Oakland, and

Request for Qualifications (RFQ) for On-Call Engineering Design Services for Non-Federally Funded Projects at the Port of Oakland

Qualifying Consultants may submit SOQs for both RFQs.

The Port anticipates executing a total of six agreements, three subject to the Federal Disadvantaged Business Enterprise (DBE) provisions incorporated into the RFQ for federally funded projects, and the remaining three subject to the Port's Non-Discrimination and Small/Local Business Utilization policy (NDSLBU) incorporated into the RFQ for non-federally funded projects. The combined total compensation for all contracts shall not exceed \$5,750,000 over the three-year term of the agreements.

Responding Consultants should carefully review the requirements of the RFQs to ensure that they meet all the stated requirements.

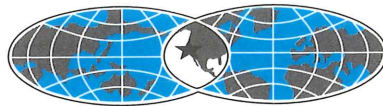
Consultants interested in submitting an SOQ for this work are invited to attend the Pre-Submittal Meeting scheduled as follows:
