## CRANE SAFETY LADDER INSTALLATION OAKLAND, CALIFORNIA (RE-BID)

The work of this 100 calendar day project consists, in general, of furnishing all labor, materials, appliances, tools, equipment, transportation, services and supervision required to install fall protection system on container cranes, and performing all associated work, all in accordance with the Contract Documents.

The Engineer's estimate for this project is less than \$400,000.

A California Class A contractor's license is required to bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract.

No contractor or subcontractor may be listed on a bid proposal or awarded any contract for the project unless registered with the Department of Industrial Relations (DIR) pursuant to Labor Code section 1725.5, with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a).

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

This contract is subject to prevailing wage provisions, as specified in Document 00100, Invitation to Bid, and Document 00200, Instructions to Bidders, of the Project Manual.

The Port previously conducted a pre-bid meeting for this project on March 26, 2019. The Port will conduct a second pre-bid meeting at the time and place listed below. **Attendance at one of the two pre-bid meetings is mandatory for bidders.** 

The second pre-bid meeting will be conducted at 10:00 AM on Thursday, April 25, 2019 in the Exhibit Room, First Floor, Port of Oakland Building, 530 Water Street, Oakland, California. The meeting will last approximately one hour and will address the Port's Non-Discrimination and Small/Local Business Utilization Policy, insurance requirements, bonds, Maritime and Aviation Project Labor Agreement and any other special working conditions for this contract.

## Bidders who did not attend the March 26, 2019 pre-bid meeting must attend the April 25 pre-bid meeting and must sign the attendance roster as a condition of bidding.

The Port will conduct a Site pre-bid inspection tour at 11:00 AM on Thursday, April 25, 2019 at 11:00 a.m., immediately following the pre-bid meeting.
