The work of this 120 calendar day project consists, in general, of furnishing all labor, materials, appliances, tools, equipment, transportation, services and supervision required to furnish and install new standing seam metal roof (including design and engineering details) and prepping and painting the entire building, including, but not limited to: demolition of existing roof, signage, lighting and miscellaneous building accessories, patching and repair of glulam beams, removal and replacement of rotted wood members; and performing all associated work, all in accordance with the Contract Documents..

The Engineer's estimate for this project is \$537,000.

A California Class A contractor's license is required to bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract.
