1. DOCUMENT 00100 - INVITATION TO BID, page 00100-1

REVISE the first paragraph of the Invitation to Bid to read as follows:

"The CITY OF OAKLAND, acting by and through its BOARD OF PORT COMMISSIONERS (the "Port"), will receive Bids via email as per the provisions of Document 00200, Instructions to Bidders, Paragraph 19, Bid Submission, until 12:00 noon on Monday, September 19, 2022, for the following public work:"

2. DOCUMENT 00200 - INSTRUCTIONS TO BIDDERS, page 00200-1

REVISE the third sentence of Paragraph 1, Receipt of Bids, to read as follows:

"The Port will receive bids until 12:00 p.m., on Monday, September 19, 2022."

3. DOCUMENT 00200 - INSTRUCTIONS TO BIDDERS, page 00200-8

REVISE the second sentence of Paragraph 20, Bid Opening, to read as follows:

"The bid opening will not be open to the public, but will be conducted via Zoom videoconferencing, and will commence at 12:10 p.m. on September 19, 2022."

4. DOCUMENT 02882 - MARINE FENDER SYSTEM, page 02882-4

DELETE in its entirety the second sentence of Paragraph 1.04.A.2.j.(8), reading "If the fabricator is not AISC certified per AISC 207, they must submit their quality control program documentation to the Contractor and/or the Resident Engineer for approval."

5. DOCUMENT 05010 - MISCELLANEOUS METALS, page 05010-3

REVISE Paragraph 1.05.B to read as follows:

"Work must be fabricated by an AISC Certified Structural Steel Fabricator, in accordance with AISC 207, Category ${\sf BU}$."
