### **ADDENDUM No. 1**

#### **Bid No.: 19-20/18, JLG Electric Articulating Boom Lift**

This Addendum modifies the original Bid Documents for the above referenced Bid. **Acknowledge receipt of this addendum in the space provided on the Bid Form (Attachment 2).**

**The following correction have been made to the above-referenced bid.**

The Port was notified that part number **E400AJP** has been discontinued by the manufacturer and replaced with **E4000AJPN**. As a result, the Port is modifying the “*Product Specification*”, *Enclosure A* and “*Detail Bid Form, Enclosure B*” in the Bid Document to reflect this change. Please replace both documents in their entirety and use enclosed **REVISED Product Specification and REVISED Detail Bid Form** when submitting a Bid. In addition to these new forms, bidders are required to submit other required attachments listed in the Table of Contents of the Bid Document.

**There are no other changes to Bid No. 19-20/18.**

**The following question was submitted by the deadline and is answered in this addendum:**

1. **Question:** JLG no longer manufactures Model# E400AJP. They now make the E400AJPN which is the same model, but a bit narrower.

*Answer: Please see above correction made to the Bid Document.*

**Bid No.: 19-20/18, JLG Electric Articulating Boom Lift**

The Port of Oakland (referred to herein as "Buyer") is soliciting competitive bids to purchase one (1) JLG Electric Articulating Boom Lift for our Airport Facilities Department. The Port intends to lock in pricing through this invitation for bid process and (if awarded) will issue a Purchase Order to purchase the equipment.

The Port has standardized on a specific manufacturer and model (**JLG E400AJP E400AJPN**) solution needed at the Oakland Airport and will not accept alternative or comparable brand products. The Port will only purchase **new** Articulating Boom Lift; therefore, refurbished or used are not acceptable. The Articulating Boom Lift shall be delivered completely assembled, serviced and ready to operate. All bidders must submit all manufacturer specifications, warranties, and other relevant information with their bid.

The bidder shall confirm to have sourced all Manufacturer products submitted in this offer from Manufacturer or through Manufacturer Authorized Channels only, in accordance with all applicable laws and policies at the time of purchase. In the event the products have been acquired from unauthorized channels, the Port of Oakland further reserves the right to return the products for a full refund.
