

NOTICE OF SOLICITATION OF BIDS

The CITY OF OAKLAND, acting by and through its BOARD OF PORT COMMISSIONERS (the "Port"), will receive sealed Bids at the office of the Secretary of the Board of Port Commissioners, located at Room 629, 530 Water Street, Oakland, California, until 12:00 noon on Monday, March 12, 2018, for the following public work:

ROUNDHOUSE PAVEMENT RECONSTRUCTION, FY 18 INNER HARBOR OAKLAND, CALIFORNIA

The work of this 45 calendar day project consists, in general, of furnishing all labor, materials, appliances, tools, equipment, transportation, services and supervision required to remove and reconstruct the pavement areas shown on the plans, including, but not limited to: demolition of asphalt, loading, hauling, excavation of existing materials, furnishing and installation of new pavement section; and performing all associated work, all in accordance with the Contract Documents.

The Engineer's estimate for this project is \$550,000.

A California Class A contractor's license is required to bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract.

No contractor or subcontractor may be listed on a bid proposal or awarded any contract for the project unless registered with the Department of Industrial Relations (DIR) pursuant to Labor Code section 1725.5, with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a).

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

This contract is subject to prevailing wage provisions, as specified in Document 00100, Invitation to Bid, and Document 00200, Instructions to Bidders, of the Project Manual.

The Port will conduct a pre-bid meeting at 10:00 AM on Tuesday, February 27, 2018 in the Board Room, Second Floor, 530 Water Street, Oakland, California

The Port strongly recommends that potential Bidders attend the pre-bid meeting. The pre-bid meeting will last approximately one hour, and will address the Port's Non-Discrimination and Small/Local Business Utilization Policy, insurance requirements, bonds, Maritime and Aviation Project Labor Agreement and any other special working conditions for this contract.

The Port will conduct a Site inspection tour on Tuesday, February 27, 2018, at 11:00 AM, immediately following the pre-bid meeting. Bidders should meet for the Site inspection tour in front of the access gate into the project area, at 1195 Middle Harbor Road. Bidders should contact Parm Sandhu, at (510) 627-1238, at least 72 hours prior to the scheduled tour date and time to confirm arrangements and register for the inspection tour by providing the tour participant's full name, telephone number and company name. Bidders who fail to contact Parm Sandhu as required above may not be eligible to participate in the tour.
