

NOTICE OF SOLICITATION OF BIDS

The CITY OF OAKLAND, acting by and through its BOARD OF PORT COMMISSIONERS (the "Port"), will receive sealed Bids at the office of the Secretary of the Board of Port Commissioners, located at Room 629, 530 Water Street, Oakland, California, until 12:00 noon on Monday, November 25, 2019, for the following public work:

TRUCK CHARGING STATIONS AT SHIPPERS TRANSPORT EXPRESS (STE) OAKLAND, CALIFORNIA

The work of this 239 calendar day project consists, in general, of furnishing all labor, materials, appliances, tools, equipment, transportation, services and supervision required to install 10 truck charging stations including 12.47kV overhead connection, 12.47kV/480V substation, and associated conduits and cables to provide functional truck chargers at Port STE site in accordance with the Contract Documents.

The Engineer's estimate for this project is \$1,250,000.

A California Class A or Class C-10 contractor's license is required to bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract.

No contractor or subcontractor may be listed on a bid proposal or awarded any contract for the project unless registered with the Department of Industrial Relations (DIR) pursuant to Labor Code section 1725.5, with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a).

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

This contract is subject to prevailing wage provisions, as specified in Document 00100, Invitation to Bid, and Document 00200, Instructions to Bidders, of the Project Manual.

The Port will conduct a pre-bid meeting at 1:30 PM on Thursday, November 14, 2019 in the Harbor Facilities Complex Lunch Room, 651 Maritime Street, Oakland, California. The Port strongly recommends that potential Bidders attend the pre-bid meeting. The pre-bid meeting will last approximately one hour, and will address the Port's Non-Discrimination and Small/Local Business Utilization Policy, insurance requirements, bonds, Maritime and Aviation Project Labor Agreement and any other special working conditions for this contract

The Port will conduct a Site pre-bid inspection tour at 2:30 PM, immediately following the pre-bid meeting. Bidders should meet for the Site inspection tour at the location noted above. Bidders will not be taken in Port vans to the Site.
