

NOTICE OF SOLICITATION OF BIDS

The CITY OF OAKLAND, acting by and through its BOARD OF PORT COMMISSIONERS (the "Port"), will receive sealed Bids at the office of the Secretary of the Board of Port Commissioners, located at Room 629, 530 Water Street, Oakland, California, until noon on Monday, February 24, 2020 for the following public work:

FORMER OAKLAND ARMY BASE (OAB) INNER CLAW FENCING OAKLAND, CALIFORNIA

The work of this 75 calendar day project consists, in general, of furnishing all labor, materials, appliances, tools, equipment, transportation, services and supervision required to install chain link security fence and gates, including, but not limited to: clearing and grubbing and furnishing and installing chain link security fence and gates; and performing all associated work, all in accordance with the Contract Documents.

The Engineer's estimate for this project is \$250,000

A California Class A, Class B, or Class C-13 contractor's license is required to bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract.

No contractor or subcontractor may be listed on a bid proposal or awarded any contract for the project unless registered with the Department of Industrial Relations (DIR) pursuant to Labor Code section 1725.5, with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a).

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

This contract is subject to prevailing wage provisions, as specified in Document 00100, Invitation to Bid, and Document 00200, Instructions to Bidders, of the Project Manual.

The Port will conduct a pre-bid meeting at 1:30 PM on Monday, February 10, 2020 in the Courtyard Conference Room, Second Floor, Port of Oakland Building, 530 Water Street, Oakland, California. The Port strongly recommends that potential Bidders attend the pre-bid meeting. The pre-bid meeting will last approximately one hour, and will address the Port's Non-Discrimination and Small/Local Business Utilization Policy, insurance requirements, bonds, Maritime and Aviation Project Labor Agreement and any other special working conditions for this contract

The Port will conduct a Site pre-bid inspection tour at 2:30 PM on February 10, 2020, immediately following the pre-bid meeting. Bidders should meet for the Site inspection tour at the Cul-de-Sac on Admiral Robert Toney Way, Oakland CA 94607. The Port will not provide vans to transport pre-bid meeting attendees to the site. Bidders who attend the pre-bid meeting shall use their own vehicles to proceed to the site.
