

NOTICE OF SOLICITATION OF BIDS

The CITY OF OAKLAND, acting by and through its BOARD OF PORT COMMISSIONERS (the "Port"), will receive sealed Bids at the office of the Secretary of the Board of Port Commissioners, located at Room 629, 530 Water Street, Oakland, California, until 12:00 noon on Friday, October 9, 2020 for the following public work:

**FURNISHING LABOR, EQUIPMENT, AND MATERIALS FOR
REPAIR AND MINOR CONSTRUCTION OF SECURITY FENCING
FOR PORT OF OAKLAND FACILITIES
FOR THE PERIOD COMMENCING JANUARY 1, 2021
AND ENDING DECEMBER 31, 2021 OR 2022
OAKLAND, CALIFORNIA**

The Work of this Contract consists, in general, of furnishing both scheduled and on-call general construction services for repair and minor construction of security fencing for Port of Oakland facilities for the period indicated. The estimated cost of Work to be performed under this contract is approximately \$150,000 per year, but in no case will the cost of Work to be performed under this contract exceed \$300,000 for the maximum two (2) year term of this contract, unless subsequently approved by the Board.

To bid this Contract, Bidders must have a California Class A or C-13 contractor's license. Joint ventures must secure a joint venture license prior to award of this Contract.

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations of the State of California (DIR).

No contractor or subcontractor may be listed on a bid proposal or awarded any contract for the project unless registered with the Department of Industrial Relations (DIR) pursuant to Labor Code section 1725.5, with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a).

This contract is subject to prevailing wage provisions, as specified in Document 00100, Invitation to Bid, and Document 00200, Instructions to Bidders, of the Project Manual.

The Port will conduct a pre-bid meeting at 10:00 AM on Friday, September 25, 2020. Due to the Governor's Shelter-in-Place order, the meeting will be conducted via Zoom videoconferencing.
