1. DOCUMENT 00100 – INVITATION TO BID, page 00100-1

REVISE the third sentence of Paragraph 1, Receipt of Bids, to read as follows:


“The Port will receive bids until 12:00 p.m., on Wednesday, November 30, 2022.”

REVISE the second sentence of Paragraph 18, Bid Opening, to read as follows:

“The bid opening will not be open to the public, but will be conducted via Zoom videoconferencing, and will commence at 12:10 p.m. on November 30, 2022.”
