1. DOCUMENT 00100 – INVITATION TO BID, page 00100-1

REVISE the first paragraph of the Invitation to Bid to read as follows:

“The CITY OF OAKLAND, acting by and through its BOARD OF PORT COMMISSIONERS (the “Port”), will receive Bids via email as per the provisions of Document 00200, Instructions to Bidders, Paragraph 19, Bid Submission, until 12:00 noon on Thursday, January 19, 2023, for the following public work:”

REVISE the second sentence of Paragraph 20, Bid Opening, to read as follows:

“The bid opening will not be open to the public, but will be conducted via Zoom videoconferencing, and will commence at 12:10 p.m. on January 19, 2023.”
