



NOTICE OF SOLICITATION OF BIDS

The CITY OF OAKLAND, acting by and through its BOARD OF PORT COMMISSIONERS (the "Port"), will receive Bids via email as per the provisions of Document 00200, Instructions to Bidders, Paragraph 19, Bid Submission, until 12:00 noon on Tuesday, March 28, 2023, for the following public work:

INSTALLATION OF LARGE TRASH CAPTURE DEVICES, PHASE 1 SOUTH FIELD OAKLAND INTERNATIONAL AIRPORT OAKLAND, CALIFORNIA

The work of this 126 calendar day project consists generally of furnishing all labor, materials, appliances, tools equipment, transportation, services and supervision required to furnish and install a large trash capture device near the parking lot exit of the Oakland International Airport, including but not limited to: providing traffic control; removing and legally disposing of vegetation and soil; grading and compacting the site; furnishing and installing aggregate base and crushed rock, reinforced concrete, Old Castle Nettek with Flange, and fencing and gates; reseeding and landscaping; and performing all associated work, all in accordance with the Contract Documents.

The Engineer's estimate for this project is \$320,000.

A California Class A contractor's license is required to bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract.

No contractor or subcontractor may be listed on a bid proposal or awarded any contract for the project unless registered with the Department of Industrial Relations (DIR) pursuant to Labor Code section 1725.5, with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a).

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

This contract is subject to prevailing wage provisions, as specified in Document 00100, Invitation to Bid, and Document 00200, Instructions to Bidders, of the Project Manual.

The Port will conduct a pre-bid meeting at 1:00 PM on Tuesday, March 7, 2023. The meeting will be conducted via Zoom videoconferencing. The Zoom meeting ID is 955 4847 2821. The Port will not conduct a site tour for this project. The project site is accessible to the public via the Daily Parking area.
