1. DOCUMENT 00100 – INVITATION TO BID, page 00100-1

REVISE the first paragraph of the Invitation to Bid to read as follows:

REVISE the second sentence of Paragraph 20, Bid Opening, to read as follows:

“The bid opening will not be open to the public, but will be conducted via Zoom videoconferencing, and will commence at 12:10 p.m. on October 2, 2023.”
