NOTICE OF SOLICITATION OF STATEMENT OF QUALIFICATIONS

Request for Qualifications (RFQ) On-Call Marine Engineering Design Services for Federally Funded Projects at the Port of Oakland

The Port of Oakland (Port) is soliciting competitive statements of qualifications (SOQ) for on-call marine engineering design services for federally funded projects. The Port has secured grant funding from the U.S. Department of Transportation, Marine Administration (MARAD). The Port intends to apply for additional federal grant funding from sources, including, but not limited to, the U.S. Department of Energy and U.S. Environmental Protection Agency. The firm(s) selected will provide services for a four-year period with two one-year options to extend. The total budget for all the contracts is not expected to exceed \$10,000,000 over the initial 4-year term and any subsequent extensions. The selected firm(s) are expected to be under contract via a Professional Services Agreement with the Port by October 2024.

Firms which submitted a Response to the RFQ for On-Call Marine Engineering Design Services for Non-Federally Funded Projects at the Port of Oakland may submit an SOQ for this solicitation, however, a firm selected under that RFQ is precluded from being selected for the Marine Engineering Design services for Federally Funded Projects at the Port of Oakland contract.

MARAD has awarded the Port a grant under the Fiscal Year 2022 Port Infrastructure Development Program (FY 2022 PIDP Grant). Selected firms shall be subject to and must comply with the FY 2022 PIDP Grant General Terms and Conditions (PIDP Grant Agreement), 2 C.F.R. Part 200, and all applicable federal laws, regulations, executive orders, policies, guidelines, and requirements as they relate to the application, acceptance, and use of federal funds. Further to PIDP Grant Agreement, section 13.3 (b) and 2 C.F.R. 200.321, the Port encourages small and minority businesses, women's business enterprises, and labor surplus area firms to participate in this RFQ. It is anticipated that initial work will be focused on the FY 2022 PIDP Grant, but engineering design services may be needed on projects funded by other federal agencies.

The Port, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders or offerors that it will affirmatively ensure that any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, national origin (including limited English proficiency), creed, sex (including sexual orientation and gender identity), age, or disability in consideration for an award.

Port policy prohibits discrimination or preferential treatment because of race, color, religion, sex, national origin, ancestry, age (over 40), physical or mental disability, cancer-related medical condition, a known genetic pre-disposition to a disease or disorder, veteran status, marital status, or sexual orientation. It is the policy of the Port of Oakland to encourage and facilitate full and equitable opportunities for small local businesses to participate in its contracts for the provision of goods and services. It is further the Port's policy that no discrimination shall be permitted in small local business participation in Port contracts or in the subcontracting of Port contracts. The successful Respondent shall comply with the Port's non-discrimination policy.

To the extent that the scope of services includes work that falls under the Labor Code definition of "public works" (Cal. Labor Code Section 1720 et seq), this project will be subject to compliance monitoring and enforcement by the Department of Industrial Relations (DIR). Consultants submitting a Response, and subcontractors or subconsultants performing any portion of the work that falls under the

“public works” definition, must be registered with the DIR pursuant to DIR requirements prior to submission of the Response, and the Prime Consultant must include in its Response its own DIR registration number and the DIR registration numbers of all listed subcontractors and subconsultants that will participate in the “public works” portion of the scope of services.

Questions regarding this Request must be addressed in writing to the appropriate contact person listed under “Request Contacts”, below. All questions not directed specifically to the primary contact person must be copied to said primary contact person. Respondents are advised that questions received less than seven (7) calendar days prior to the Response due date may not be answered. Where appropriate, the Port will respond in writing to respondent questions submitted in a timely fashion via an addendum or a ‘Log of Responses to Respondent Questions’; see “Port Responses to Respondent Questions”, below.

Consultants interested in submitting proposals for this work are strongly urged to attend a Pre-Response Meeting to be held at the time/date/location specified under “RFQ Schedule”, below. At the Pre-Submittal Meeting, the Port will provide information related to the Port’s insurance requirements, federal grant requirements, and will answer questions regarding the proposed project, submittal requirements and the selection process.

The Port reserves the right to reject any or all Responses, to waive any irregularities or informalities not affected by law, to evaluate the Responses submitted and to award the contract according to the best interests of the Port.

Note that, as per Section II.D, properly executed copies of all forms contained in Attachment 3 must be included in the Responses. Submitted PDF must be unencrypted, universally viewable, printable, transferable and enable copy.
